Greetings from the Messianic Israel Alliance (MIA) Representing the Proposed Provisional Israelite Council in Exile.

We send our most sincere and heartfelt wishes for your continued success in the coming year, and our desire for your nation to enjoy the blessings of our Creator as you face the challenges of our times.

The goal of the Proposed Provisional Israelite Council in Exile is to assist in the reunification of the scattered tribes of Israel, and allow them a way to return to their historical homeland, located in biblical Samaria and Judea, and to eventually live in all the land promised to Abraham, Isaac and Jacob.

We do not claim, nor will we claim, any right to rule, replace, or subvert, the existing national government of Israel, nor do we wish to damage in anyway the lawful and legally elected Government of Israel, or the people of Israel who currently reside within the territory of modern day Israel.

We, instead, wish only to express our inalienable right of return to our biblical inheritance and historical territory, located in current day Samaria and Judea, otherwise known as the West Bank or Occupied Territories, and be allied in firm friendship with the current nation of Israel in her fight to survive into the future.

Since the government of Israel is planing to relinquish any claim or rights to portions of the West Bank, East Jerusalem, and has already given up Gaza as being a part of the present State of Israel, we ask that your government assign any possible right, title or interest that they may have in these territories, to the Proposed Provisional Israelite Council in Exile which we are in the process of forming.

Taking a cue from our forefather Jacob who purchased ground at Shechem from the sons of Hamor for one hundred pieces of money, we hereby offer to remunerate the government of Israel one hundred pieces of money. One hundred silver half-shekels for the assignment of any possible right, title and interest that the government of Israel may have in or to these territories (Joshua 24:32).

We once again state our intentions to act as an agent of reconciliation and reunification of all the tribes and people of Israel, as described in the Holy Bible, and our wishes to form an alliance of common cause with the present nation of Israel, and the Jewish people, whom we consider to be our brethren. We do so out of necessity, and with utmost sincerity, due to the crisis of humanity that we are currently experiencing, and the stated intentions of some to destroy the entire nation of Israel and her people throughout the world.

If any of the foregoing provisions are acceptable to the Government of the Nation of Israel, we would like to begin the process of establishing formal ties with the Nation of Israel, and explore the process of establishing a mutually fruitful relationship.
